## NOTICE OF AMALGAMATION

Please be advised that **Sinopec Daylight Energy Ltd.**, **Sinopec Canada Energy Ltd.**, and **SinoCanada Petroleum Corporation** (i) were continued into British Columbia on November 27, 2023 and extra-provincially registered in Alberta (and, in the case of Sinopec Daylight Energy Ltd., in Saskatchewan); and (ii) have amalgamated effective January 1, 2024 and were extra-provincially registered in Alberta and Saskatchewan. 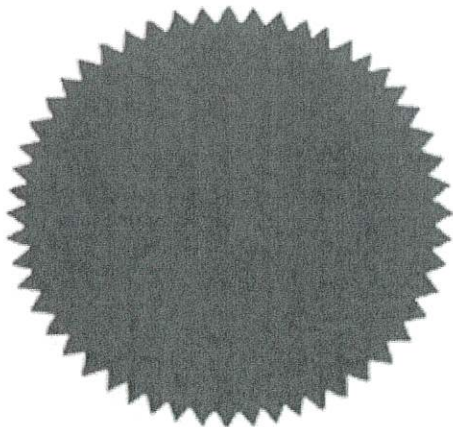
